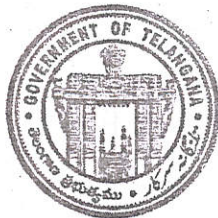

AMENDMENT TO THE TELANGANA STATE LEGAL SERVICES AUTHORITY REGULATIONS, 2016.

NOTIFICATION NO.05/TSLSA/2019

Roc. No.3616/TSLSA/2019. In Exercise of powers conferred under Section 29A of the Legal Services Authorities Act, 1987, the Telangana State Legal services Authority hereby makes the following Amendments to the Telangana State Legal Services Authority Regulations, 2016.

1. "For the figure shown at Sl.No.3 at Col.No.4 i.e. "Rs2,500/-" against National Lok Adalat shall be substituted with the figure "Rs.10,000/-" and the figure shown at Sl.No.4 at Col.No.4 i.e. "Rs.1,000/-" against National Lok Adalat shall be substituted with the figure "Rs.5,000/-" in Regulation No.24 of Telangana State Legal Services Authority Regulations, 2016.
2. "For the figure and words "Rs.3,000/- (Rupees three thousand only)" shall be substituted with the figure and words "Rs.10,000/- (Rupees ten thousand only)" in Regulation 26 of Telangana State Legal Services Authority Regulations, 2016.
3. The following shall be added as Regulation 21A in Telangana State Legal Services Authority Regulations, 2016.

"Legal Services not to be provided in certain cases:- Legal services shall not be given in the following cases, namely:-

- (1) Proceedings wholly or partly in respect of :-
 - (a) defamation; or
 - (b) malicious prosecution; or

- (c) a person charged with contempt of court proceedings; and
(d) perjury.
- (2) Proceedings relating to any election.
(3) Proceedings incidental to any proceedings referred to in sub-regulations (1) and (2).
(4) Proceedings in respect of offences where the fine imposed is not more than Rs.50.
(5) Proceedings in respect of economic offences and offences against social laws, such as, the Protection of Civil Rights Act, 1955, and the Immoral Traffic (Prevention) Act, 1956 unless in such cases the aid is sought by the victim:
(6) Where a person seeking legal services:-
(a) is concerned with the proceedings only in a representative or official capacity; or
(b) is a formal party to the proceedings, not materially concerned in the outcome of the proceedings and his interests are not likely to be prejudiced on account of the absence of proper representation.

The above amendments shall come into force on and from the date of the publication in the Telangana State Gazette.
