TENDER TERMS & CONDITIONS :

1. The vehicle will be auctioned as **scrap "AS IS WHERE IS BASIS"**. The vehicle can be inspected from 05-09-2023 to 12-09-2023 on any working day between 10.30 Am. to 5:00 P.M. at Telangana State Legal Services Authority, Nyaya Seva sadan Buildings, City Civil Court Premises, Hyderabad. (Closed on sunday) for inspection of vehicle. The auctioneer is not responsible for the quality and defects etc. of the vehicle. Once an offer is accepted successful bidder will have to make the vehicle as scrap.
2. Every intending bidder will have to register themselves by way of depositing Rs.3000/- in cash as security deposit (refundable) at least 1 hour before the scheduled time of auction which may be adjusted/refunded later on to the successful/unsuccessful bidder.

3. The successful bidders will not be allowed to withdraw his bid. In case the successful bidder withdraws his bid, his Earnest Money Deposit will be forfeited.
4. The successful bidder shall have to deposit full payment against their bid as soon as the bid is over in cash to the under signed , after adjusting the security deposit on the spot.
5. The Successful bidder should make the vehicle cutting into pieces after auction and should surrender the said vehicle chassis number and Engine Number and Number plates to the undersigned in the prescribed time and no registration certificates would be issued.
6. After depositing the full bid amount, the bidder shall lift/remove the auctioned vehicle within a period of 03 days from the site. If the vehicle is not lifted/removed within the said period, this Authority shall not be responsible for its safe custody, and also the bidder shall not have the right or claim for the vehicle and the bid amount deposited shall be forfeited. The vehicle shall be lifted at the risk and responsibility of the tenderer.
7. The delivery of the scrap vehicle will be arranged only after the successful bidder submits necessary documents and evidence in support of residential status viz, Aadhar Card/Voter identity Card/Passport in case of individual and Registration Certificate in case of firms etc.
8. The successful bidder will make his own arrangement for transport and he will not be entitled to claim any facilities or assistance for removal or transport of articles from this Authority.
9. The undersigned has the right to reject all or any bids without assigning any reason and decision of the Member Secretary TSLSA on behalf of APSLSA of all other matters relating to the auction shall be final.
