DURING THE YEAR 2015

(1). INAUGURATION OF FREE LEGAL AID AND ADVICE CENTRE :-

A Free Legal Aid and Advice Centre was set by Telngana State Legal Services Authority at Stall No.841 in the 75th All India Industrial Exhibition which was inaugurated by *Hon'ble Sri Justice K.C.Bhanu*, Executive Chairman, TSLSA on 8-1-2015 at 6.00 PM. *Sri G.Shyam Prasad*, Member Secretary (FAC), TSLSA, *Sri V.Srinivasa Sivaram*, Administrative Officer (I/c), TSLSA, Advocates, Staff Members, Office Bearers of Exhibition Society, Press and Electronic Media and visitors have attended in Inaugural function.

Fareeda, PLV is selected as the best Para Legal Volunteer for the commandable work done by her. a) She helped three rape victims to get financial aid from Women and Child Welfare Department, Medak District as per the G.O.Ms.No.28(WCD/SC Department) dated 13-04-2011 and she further made that the said compensation amount is deposited in fixed deposit till the victim girls attain the age of majority and she also took the rape victims to Government Hospital for necessary treatment and also counseled the victim girls and their parents to face the situation and not to accede to depression.

Smt Fareeda rescued a poor farmer by name M.Sangameshwar when he attempted to commit suicide due to financial problems. She held counseling to the said farmer and to the money lender and made the money lender to refund an amount of Rs.1 lakh to the poor farmer (borrower).

She was honoured and felicitated by the Hon'ble Prime Minister of India, Sri Narendra Modi in the august presence of Hon'ble Sri Justice T.S.Takur, Judge, Supreme Court of India and Executive Chairman, NALSA (as His Lordship was then) and Hon'ble Sri Justice Anil R.Dave, Judge, Supreme Court of India and Chairman, Supreme Court Legal Services Committee (As His Lordship was then) and Sri D.V.Sadanand Gowda, Hon'ble Law Minister, Government of India and other dignitaries.
