Success Stories From January, 2022 to August, 2022 in the State of Telangana

- DLSA, Khammam received an application from someone regarding excess collection of amount by the Gas Delivery Boy. DLSA, Khammam has summoned the District Civil Supplies Officer and explained about the problem, in turn the Officer has instructed to all the Gas Agencies not to collect excess amount.
- ▶ Upon perusal of a newspaper article published on 09.02.2022 in Eenadu Main Edition with respect to abandonment and forceful eviction of old aged couple namely Sri Ramanna and Smt. Kistamma by their sons three months back upon tranferring their land of Ac. 3-20 gts., and since then the said old age couple are residing in a KIOSK at Amarchinta on a monthly rent of Rs. 300/-.

Basing on the above, Suomoto cognizance was taken by MLSC, Mahabubnagar district registered PLC No. 01/2022 and issued notices to the sons of old age couple and after conducting negotiations and mediation between the parties and the matter was settled amicably.

A case in MVOP No.136/2021 on the file of III Addl. District Judge's Court, Karimnagar filed by the petitioner No. 1 to 4 u/s 166(1)(C) of M.V. Act against the respondent Nos. 1 to 4 of claiming compensation of Rs.90,00,000/- on account of death of Dorgam @ Durgam Mogili, S/o Lingaiah i.e. the husband of the petitioner No.1 in a road accident that occurred on 19-09-2020 at 04.00 P.M. In view of the special efforts put in by the DLSA, Karimnagar and Lok Adalat Bench, the matter was settled amicably on 12.03.2022 between both the parties and an amount of Rs. 75,00,000/- was awarded to the Petitioners No. 1 to 4.

- A case in G.W.O.P. No. 19/2016 was filed by a father before the III Addl. District Court, Gadwal on 24.08.2015 for custody of minor Child namely M.Dharma Murthu Sai @ Sai Rakshith from the mother. The marriage of Petitioner and Respondent was solemnized on 14.05.2011. On 29.09.2012 the Respondent gave birth to M.Dharma Murthy Sai @ Sai Rakshith and due to some differences the respondent i.e., wife of the Petitioner left the company of the Petitioner on 22.7.2015. After Six years of filing of this Guardian Wards O.P., the Petitioner and Respondent came to the Mandal Legal Services Committee, Gadwal during National Lok Adalat held on 12.3.2022 and after successful Mediation and Conciliation the parties agreed for amicable settlement and to live together and lead a happy marital life thereafter and accordingly the matter was settled in National Lok Adalat on 12.03.2022.
- A petition filed by the Resident of ward No.22 Bhagiratha Colony, Mahabubnagar stating that the local municipal authority suddenly released the water from a tank Pedda Cheruvu due to which the drainage water seesed into Bore wells and drainage water contaminated. from their Bore wells. The DLSA. Mahabubnagar has issued notices to the Municipality, Mahabubnagar and after conciliation the Department responded positively and immediately constructed a Protection wall and diverted the drainage water.
- The District Legal Services Authority, Mahabubnagar has arranged Lunch at nominal rates at the Central Library, Mahabubnagar with the assistance of the Municipal Commissioner, Mahabubnagar, Chairman of Central Library and PLV of DLSA. The DLSA has entrusted the matter to a Para Legal

Volunteer, who visited the Library and informed that there are more than 200 students/un employees are preparing for competitive exams from morning 8.00 a.m. to Evening 6.00 p.m. and some of the women are due unable to carry their Lunch due to their poor financial condition. The DLSA has addressed a letter to the local Municipal Commissioner, Mahabubnagar and he responded positively and agreed to provide Rs.5/- lunch at the Central Library, Mahabubnagar. On 14.04.2022 on the occasion of Dr. B.R Ambedkar Jayanthi, the Secretary, DLSA and the Chairman of the Central Library have inaugurated Rs.5/- lunch at the Library for the convenience of poor and needy students/Un-employees and it is in progress. Due to the efforts of DLSA, student/un-employees are getting immensely benefited.

- On 30-05-2022, Sri Sura Sab C/o H.No.6-89, Srinagar village, Gundaram, Nizamabad, aged 64 years came to District Legal Services Authority, Nizamabad for temporary shelter as his sons have deserted him and he made an application before the authority to provide necessary shelter till the dispute is resolved. The Secretary, DLSA has addressed a letter to the Supervisor, Nirmala Bhavan, Shasthrinagar, Nizamabad to provide necessary shelter to Sri Sura Sab R/o Nizamabad till the dispute is resolved. Accordingly, Sri Sura Sab was provided shelter at Nirmala Bhavan on the intervention of DLSA, Nizamabad.
- One Old Aged Person namely Joseph age: 76 years, blind person, who was necked out by his son-in-law, at Lothkunta bus stop was rescued by the Para Legal Volunteer of CCCLSA, Hyderabad and admitted in Old Age Home with the assistance of local police.

- One Old Aged Woman, namely Raja Amma, aged:70 years, who was unconscious on the main road of Tirumalagiri, Secunderabad and was necked out by her son from her own house was rescued by the Para Legal Volunteer and admitted in Old Age Home situated at Secunderabad with the assistance of local police.
- On 06.06.2022, One Old aged person, namely christopher age, 75 years, was stand alone in Bansilalpet X roads, Hyderabad and public informed that he was roaming on roads alone since few days. After verification by Police, he was admitted in Mathrushri Old Age Home, Thimmaipally Village, Shameerpet Mandal by Para Legal Volunteers of Ranga Reddy district.
- During the process of identification of old cases for referencing to National Lok Adalat, an oldest suit OS No. 53/1003 pending before the Prl. Senior Civil Judge, Khmamm was identified. The matter related to distribution of joint property among (21) family members.

During the pendency of the suit, (2) dependents died and their legal heirs were brought on record. With the conciliation efforts, long pending suit was amicably settled between the parties and Lok Adalat Award was passed. Accordingly, giving finality to a long pending dispute among the family members.

A news item was published in "Eenadu" daily news paper under the caption "Daari kachina ... pramadam". The contents of news item are that an electric poll on the route of Kapsi to Sangdi village, Adilabad district is bending down on the road and became dangerous for the village people who are traveling on the road. Immediately, the DLSA, Adilabad has issued notice to officials of Electricity Department and directed them to take steps for immediate repairs. On the next day the electricity officials

- fixed a new electrical poll. Due to the efforts made of DLSA, the difficulty faced by the villagers was resolved.
- A news item was published in "Eenadu" daily news paper under caption "Ponchiunna pramada". The contents of news item are that, the culvert near Ponnari village is damaged during the rainy season and became danger for vehicles moving on that road. The DLSA, Adilabad immediately issued notice to R & B officials and directed them to take immediate steps. The R & B officials immediately made repairs to the road and solved the problem.
- A news item was published in "Eenadu" daily news paper under caption "*Rahadari chidram...prayanam narakam*". The contents of the news item are that, the R & B Departments started repairing the road towards Jainath to Bela, but the contractor stopped the work due to non sanction of budget. The DLSA, Adilabad has issued notice to R & B Officials to sanction the budget immediately and complete the work. Accordingly, the R & B Officials sanctioned Rs.86 Lakhs budget and the commenced the work. Due to the efforts made by the DLSA, the grievance was solved.

On 14-07-2022, the District Legal Services Authority, Nizamabad has organized a Legal Awareness Camp at Nyaya Seva Sadan, Nizamabad. In the programme the Prl. Dist. & Sessions Judge-cum-Chairperson and Secretary, DLSA, Nizamabad enlightened the Participants on the topics of NALSA (Victims of Trafficking and Commercial Sexual Exploitation) Scheme, 2015, NALSA (Effective Implementation of Poverty Alleviation Schemes) Scheme, 2015, DLSA Activities.

Further, a New Two Wheeler Vehicle TVS Scooty Pep Plus brand provided by the District Collector, Nizamabad and respected Addl. District Collector, Nizamabad to Asadi Alka who is a Transgender (Male to female) working as Office Subordinate on outsourcing basis at DLSA, Nizamabad. The two wheeler vehicle was temporarily registered in the name of Alka and delivered to the DLSA, Nizamabad for the use of Transgender employee.

- On 17-07-2022, one old age woman was found unconscious at Secunderabad Bus Stand and with the help of Police and senior citizen helpline, PLV of City Civil Court Legal Services Authority, Hyderabad has rescued and admitted her in Gandhi Hospital, Secunderabad.
- A person named Robert aged 60 years was roaming in the streets of sastrinagar, Tirumalagiri, with a woman Krishnaveni who is his relative as his family members are not looking after them. The Para Legal Volunteers noticed and joined in Mathrushri Old Age Home, Alliabad Shameerpet.
- Upon the request made by one Sri Suresh for heart Surgery of his two months baby B/o Sony (Aradhya), the Chairperson, City Civil Court Legal Services Authority, Hyderabad has addressed letters to the Medical & Health Department and as per the instructions of the Secretary, CCCLSA, has coordinated and arranged Free Surgery at Rainbow Hospital on 01.08.2022.

As the heart operation was successful, the parents of the infant approached City Civil Court Legal Services Authority, Hyderabad and expressed their gratitude.

- A news item was published in "Eenadu" daily news paper under caption "Badilone pashu vaidyam, vinedela patham". The contents of news item are that, the Veterinary Hospital building at Sirikonda Village was handed over to the Tahsildar, Sirikonda and as such the veterinary hospital is running at school premises of Sirikonda village and due to which the students facing inconvenience. Immediately the Secretary, DLSA, Adilabad has directed the Chairman, MLSC, Boath to visit the school premises. The Chairman, MLSC, Boath inspected the school premises and issued directions to the concerned officials to shift the Veterinary Hospital to another place.
- A news item was published in "Eenadu" daily news paper under caption "Ponchiunna pramadam". The contents of news item are that, the culvert near Landasangvi village is damaged during the rainy season and became dangerous for vehicles paying on that road. The Secretary, DLSA, Adilabad has issued notice to R & B officials and directed them to take immediate steps. The R & B officials immediately made repairs to the road and the problem was rescued.
